

Undergraduate Brother of the Year

- The undergraduate brother of the year must have been financial on the National and Chapter level for at least the past two (2) consecutive years,
 - The undergraduate brother of the year must have a cumulative 2.75 GPA,
 - The undergraduate brother of the year must have performed at least 50 hours of community service within the last calendar year,
 - The undergraduate brother of the year must have attended at least 2 professional IOTA events in the last academic calendar year, and
 - The undergraduate brother of the year must be an active member within the region and/or chapter for at least 2 years and have held (or currently holds) at least 1 leadership role within his chapter/region.
- To apply for the Undergraduate Brother of the Year award, please submit an official transcript (sealed), copy of financial receipt, list of the community service hours/ projects, list of professional IOTA events attended, leadership role(s) held previously (or currently holds), a resume, and an essay *on why this brother should be selected as Undergraduate Brother of the Year, along with how this brother serves as a role model for other undergraduate brothers in the Region.*

Undergraduate Chapter of the Year

- The undergraduate chapter of the year recipient must be financial (National and Chapter),
 - The undergraduate chapter of the year recipient must have a cumulative GPA of 2.75 (including all members on the roster),
 - The undergraduate chapter of the year recipient must have performed at least 150 documented community service hours within the last calendar year,
 - The undergraduate chapter of the year recipient must have hosted at least 5 significant events within the last calendar year, and
 - The undergraduate chapter of the year recipient must have participated in national and regional activities.
- To apply for the **Undergraduate Chapter of the Year**, please submit a copy of financial receipt, official transcripts for each chapter member, an updated roster of all chapter members, list of community services hours/projects, list of events hosted during the last calendar year, list of events participated on the national and regional level, and an essay on why this undergraduate chapter should be selected as **Undergraduate Chapter of the Year**, *explaining why this chapter feels they should be selected as the chapter of the year and what makes them stand out/excel compared to other chapters in the Region.*

Alumni Brother of the Year

- The alumni brother of the year must have been financial on the National and Chapter level for at least the past two (2) consecutive years,
 - The alumni brother of the year must have performed at least 50 hours of community service within the last calendar year,
 - The alumni brother of the year must have be an active member within the region and their alumni chapter for at least 2 years,
 - The alumni brother of the year must have attended at least 3 professional IOTA events within the calendar year, and
 - The alumni brother of the year must be an active member within the region and/or chapter for at least 2 years and have held (or currently holds) at least 1 leadership role within his chapter/region.
- To apply for the **Alumni Brother of the Year** award, please submit a copy of financial receipt, list of the community service hours/projects, list of professional IOTA events attended, leadership role(s) held previously, or currently holds, a resume, and an essay on why this alumni brother should be selected as **Alumni Brother of the Year**, *elucidating how this alumni brother demonstrates Brotherhood and serves as a role model for undergraduate brothers and demonstrates leadership within the fraternity and local community.*

Alumni Chapter of the year

- The alumni chapter of the year must be financial (National and Regional),
 - The alumni chapter of the year must have performed at least 100 community service hours within the last calendar year,
 - The alumni chapter of the year must have participated in at least national or regional event,
 - The alumni chapter of the year must have hosted at least 3 annual events within the last calendar year, and
 - The alumni chapter of the year must have worked closely with an undergraduate chapter within their area, serving as a mentor (and/or advisor).
- To apply for the **Alumni Chapter of the Year**, please submit a copy of financial receipt, an updated roster of all chapter members, list of community services hours/projects, list of events hosted during the last calendar year, list of event (s) participated in (either at least national or regional level), and an essay on why this alumni chapter should be selected as **Alumni Chapter of the Year**, *explaining how the chapter exemplifies the motto, "Building a Tradition, Not Resting Upon One,"* actively provides leadership to the undergraduate chapter and citizenship within the local community.

The Karl A. Roberts Sr. Citizenship Award of the year (Individual)

- The KR Citizenship award of the year recipient must be financial (National and Chapter);
 - The KR Citizenship award of the year recipient must have performed at least documented 50 hours of community service within the last calendar year,
 - The KR Citizenship award of the year recipient must have attended at least 3 professional IOTA events in the last calendar year,
 - The KR Citizenship award of the year recipient must have been in the fraternity for at least 2 year (either undergraduate or alumni) and must have been active both years,
 - The KR Citizenship award of the year recipient must have participated (assisted) in at least 1 professional IOTA event within the last calendar year, and
 - The KR Citizenship award recipient of the year must demonstrate the spirit of the late Bro. Karl A. Roberts Sr. through demonstrated leadership, commitment, role modeling.

- To apply for the **Karl A. Roberts Sr. Citizenship Award** of the year, please submit a copy of financial receipt, list of community service hours/projects, list of events attended during the last calendar year, list of events participated within the last year, and an essay on why this nominee should be elected as the **Karl A. Roberts Sr. Citizenship Award of the Year**, *explaining their impact, involvement, etc. in the local community and how they have exhibited the start of citizenship.*

Community Servant Award (Undergraduate or Graduate)

The Community Servant Award will be presented to a brother who has shown a commitment to service throughout his surrounding community.

- Nominee must have performed at least 50 documented service hours
- Nominee contributes to their campus and/or surrounding community through active hands-on service
- Nominee exemplifies the qualities of being selfless and concern about the well-being of others.
- Nominee inspires additional participation of their peers

To apply for the **Community Servant Award**, please submit copy of financial receipt and list of community service hours within the last year.

Neophyte of the Year Award (Undergraduate or Graduate)

The Neophyte of The Year Award is presented to a brother that has distinguished themselves during their first year of membership within the fraternity.

- Nominee must have joined the organization between January 1st 2016 through March 1st 2017.
- Nominee should have shown exceptional service during their first year of membership through their participation in the chapter, the Fraternity, and surrounding community.
- Nominee shows commitment and is positioned to make a positive impact within their chapter and surrounding community.

To apply for the **Neophyte of The Year Award (Undergraduate or Graduate)** award, please submit an essay on why this brother should be selected as Neophyte of the Year, especially explaining the contributions he has made within his chapter/community.
